

To the Premier of N.S. Mr. Tim Houston; N.S. Chief Medical Officer, Dr. Strang; N.S. Legislative Assembly;

Introduction:

Hello, my name is_____. I was born here in _____, NS, and I am a proud community member living in one of the greatest Provinces Canada has to offer.

In this letter, I would like to present to you information that challenges the current narrative of Covid-19, and raise concerns regarding the vaccines, Covid testing, and vaccine passports—to mention a few. I will present examples of how I feel this new vaccine passport mandate is infringing on the sovereign rights, freedoms, religion, health, and wellness of the great people of this Province. I will provide examples, excerpts, data, and expert medical knowledge.

Part 1: Rights and Freedoms

My first concern is the requirement of vaccine passports, mandates, medical procedures, and collection of DNA by Government and business establishments—is (in my opinion) in violation of:

- human rights
- physical health and well-being
- mental health and wellness
- genetic integrity
- the right to not to disclose or engage in medical testing
- religious, spiritual, ethical, and philosophical beliefs
- a person's dignity
- freedom of choice and informed consent
- a person's right to medical privacy, and

This mandatory vaccination policy is contradictory to the values that Nova Scotia and Canada continuously strive to stand for. In my humble opinion, failure to consider the possibilities in this letter could be extremely ruinous and detrimental to anyone subjected to implementing such policy. - BILL S-201 – An Act to prohibit and prevent genetic discrimination
- Nova Scotia Human Rights Act, as well as,
- Nova Scotia Occupational Health and Safety Act

Part 2: Confidentiality and Informed Consent

In healthcare—confidentiality and the hippocratic oath to do no harm was always the golden rule that must never be broken. They are sacred and should be upheld with the highest integrity and morality. Correspondingly, all citizens have the right to maintain privacy of confidential medical information; as well as, their vaccination status. DNA and medical results from testing should not be disclosed to anyone except the person and their healthcare practitioner stated by the many rights and Acts given to us by the United Nations, Canada, and Nova Scotia. I feel it is important to restore the relationship between the patient and physician, and take away the control and authority over a person's medical choices from our Government and business establishments.

Part 4: PCR Test Swabs

My third concern is the safety of the Covid-19 tests, which is most often a medical procedure in which a person sticks a swab up their nose to collect DNA in order to conduct a PCR test. Part 5: Graphene Oxide

Another alarming ingredient is one that the swabs, "vaccines", and even surgical masks all share in common. It is an ingredient called **Graphene Oxide**. Part 8: Finding the Right Information

Disclaimer. this next part should not be taken as fact, rather, it is my personal opinion and view.

Important to note: there are two sides of information; the side that makes the claim, and the side in opposition to that claim. When there is opposition, especially to a medical claim, that stems controversy. When there is controversy, the claim needs to unequivocally be proven and verified by the side that makes the claim. In this circumstance, we have two sides each making their own claims. One side is making a claim that the vaccines and testing method is safe. The side which is in opposition is claiming they are unsafe. The onus lies on each side to produce facts, evidence, data, and demonstrate their claim with objective and irrefutable proof.

Using tools like fact-check and information given by the WHO, CDC, and FDA is not necessarily enough evidence to prove something one way or another. These tools can sometimes be helpful, however —if Governments & affiliated Agencies are simply unaware of facts, data, statistics, evidence, and expert medical opinions—they can only provide what information they currently have.

As information becomes more readily available and updated over time, these Governments & affiliated Agencies may change their position on particular issues. In this particular case, there is so much censorship that information is not being brought to light. We all need to exercise our Due Diligence and make sure the decisions we make are in the best interest of the safety of all people, and decisions that do not infringe on people's Rights. This is such a complex issue, but we must take all information into account and reassess when new information is presented.

I do not state any of these claims as some conspiracy theorist. When seeking information I gather from the top and most renowned experts in the fields and verify their information that correlates with other top medical experts, data, facts and statistics.

Here are some questions I would simply like you to consider when making such policies:

- **What if the World Government affiliated Agencies are all wrong about how deadly Covid-19 really is?**
- **What if the prevention tactics of Covid-19 cause more damage then they're aimed to reduce?**
- **What if the vaccines and testing methods actually cause more harm and damage than good?**

(Since the Covid vaccine is relatively new, the long-term side effects are not known yet)

- **What if they carry serious and detrimental implications for generations to come?**
- **How does this policy negatively impact the rights and well-being of others?**
- **What if the vaccine passport means Governments and Business establishments can simply mandate anything they want and we simply have to abide due to fear of repercussions**

These questions are not ones I expect anyone to answer. The purpose of these questions, and even this letter, is meant to provide a foundation to enrich the minds of whoever reads this, strike curiosity in the hearts and souls, and let reader ponder and contemplate the depth and philosophical nature of the seriousness this entails. Consequently, my goal here is not to tell anyone not to receive the Covid-19 vaccine or test. I believe in the sovereignty and freedom of a person to choose what is best for themselves, as well as the right of informed consent for all people. The moment something becomes a mandate with two bad options to pick from (in my personal opinion), that freedom of choice is now robbed from them. The goal is to revoke the vaccine passport idea and any notion of mandatory vaccines—and/or medical treatment, procedures, tests, or collection of DNA.

Part 9: Covid-19 Statistics

My fourth concern is: **who will be liable if a person receives these experimental mRNA injections (“vaccines”), or medical DNA test, and has serious adverse reactions?** If a

person were to be permanently injured or fatal (hypothetically), they would be left with no quality of life, and their family would have no compensation if something negative and severe were to happen to them. Even if a person or company would assume liability, the risks still outweigh any amount of compensation. Children cannot afford to be without a parent, nor should they have to endure that burden and hardship as a result of an unnecessary and unwanted medical procedure.

An argument could be made stating as such: "although vaccines do in fact pose risk [statistically proven by VAERS and multiple other vaccine statistics programs], the risk of contracting Covid-19 poses a larger risk".

My response to that argument would be: According to Government statistics in Nova Scotia from March 1st 2020 – May 31st 2021:

- N.S. population – 979,351
- Covid-19 deaths in – 85
- **Overall fatality rate – 0.01%**
- **Survival rate – 99.99%**
- Total PCR tests taken – 816,858
- Total confirmed PCR tests and probable – 5,567
- % Tested positive – 0.68% (5,567 / 816,858)
- % Tested negative – 99.32% (816,858 – 5,567 / 816,858)
- # Patients in ICU – 16
- # Patients hospitalized with Covid – 40 (includes those in ICU)
- 54 out of 85 deaths occurred at Northwood Long-Term Care Home
- Average age of deaths with Covid – 79
- Average Provincial life expectancy – 80.4

By stating these statistics I am Not implying Covid should not be taken seriously, nor am I denying the legitimacy of a virus that is negatively affecting people. My personal opinion based on statistics, evidence, and an overwhelming amount of expert medical opinions— is that Covid-19 is simply not killing people at the rate the Media, Governments, and public health officials portray it. Equally important, these mRNA –Gene Therapy– Experimental Injections ("vaccines") do not seem to provide any better solution to increasing a person's health. Part 12: Requests

My fifth concern is that I am left wondering is, what will happen to citizens for choosing to exercise their **Right to Not Consent to**:

- anything we deem unsafe until it is unequivocally proven safe to me
- anything that goes against our health & wellness
- anything that violates our confidential personal information
- anything that violates our human rights

- anything that we deem lessens our dignity as a person, and
- anything that intrudes, invades, restricts, or hinders our personal beliefs and knowing

In the case that Mr. Premier and Dr. Minister of Health does not consider the provided evidence here, and continues to take an opposing position towards my presented evidence: I would like to submit the following requests:

- can you please provide proof the vaccines are safe AND effective
- can you please provide proof the testing methods and products are safe and effective
- can you please provide proof that our Government has legal right to mandate vaccinations, medical testing procedures, collection of DNA & results by Federal Law, Provincial Law, and International Law
- can you please provide proof these vaccines are fully FDA approved, not just FDA authorized; and distinguish the difference between them
- can you please provide proof the of virus (Covid-19) and variant of which we are being mandated to treat ourselves for, by an isolated sample of it from humans
- can you please provide proof that these vaccines do not cause harmful or severe adverse reactions (phrases like "in rare cases" could be subjective and negated)
- can you please state publicly how many people died in Nova Scotia from Covid-19 thus far, and how many were in ICU of Covid-19 in relation to the number of population. And state a statistical mortality of Covid-19 based on statistical evidence
- can you please provide liability by the Government in written forms stating that citizens will be fully compensated by our Government if such case that someone is harmed and unable to work as a result of medical treatment, procedures, or testing by requirement of our Government

I do not believe it is unreasonable to think there are safety concerns with the "vaccines" based on the evidence I presented in this letter. I have shown many examples and exhibits for all my concerns. These are legitimate concerns that any reasonable person would have. They are based on countless medical expert's knowledge and experience, and ethical principles guided by many Legislative Acts. Thousands of Doctors are all coming forth with this alternative information that I've briefly demonstrated here. Moreover, tens of thousands of testimonials from "vaccine" side-effects are coming forth as well. Is it often disregarded as being "internet-based fake news"; however, these are real people with real stories to share. They are individuals, not just a group of "internet people". Albeit, much of this information I'm sharing comes in the form of video, and it is deeply in opposition to most mainstream information. In contrast, I do not believe it should automatically be dismissed. The amount of information that challenges the safety of these "vaccines" and testing procedures & products is overwhelming. Given the extremely high number of Doctors and medical experts all around the world whistleblowing about these "vaccines" and testing methods should hopefully indicate there is at the very least merit behind these claims.

With all due respect, I understand the narrative given by many Governments & affiliated Agencies (i.e. the CDC and WHO), is that these experimental injections are thought to be vaccines in the traditional sense of how we view them. And that these "vaccines", along with the testing methods, are safe and effective. On the other hand, when determining if this given information is actually true and accurate, we must consider all sides of data produced by medical experts, especially facts and evidence before ruling out what is true or false. Since there is no consensus on this, and since there is controversy and lawsuits against these organizations and Governments around the world; I don't feel we can necessarily claim these "vaccines" are safe and effective until undoubtedly and unequivocally proven to be true. For this reason, since the vaccines have yet proven to be safe, and their adverse side effects and ingredients are controversially being censored—that is my basis for feeling these "vaccines" and testing methods could be detrimental and harmful, and that we cannot assume they are safe when there is so much evidence proving otherwise.

I respect the fact that much of this information I am providing in this letter may have been unknown to most people. That is due to the massive censorship of this information, and anything or anyone that challenges the Status Quo. I do not believe the policy was created with malice or ill-intentions; I believe it was created with the goal to help and serve our community better under the notion that these experimental injections were thought to be "vaccines", and that vaccines are supposed to be safe and effective.

Part 13: How I am Affected

Since Nova Scotia's vaccine policy rollout, the lack of clarity and thought of disciplinary action for refusal of the policy (for which I undoubtedly know the "vaccine" will harm me), has caused me great fear, which leads to constant **Extreme Anxiety and Distress**. This overall is causing depression within me. I have constant insomnia, nightmares, panic attacks, feelings of doom, and a lack of energy—zest—and zeal. I value my life, the security of my life, and the sanctity of all life. I desire the **Right to Choose** what is best for myself. I do not wish to have medical procedures done to me against my will, my conscious, my innate rights & dignity, or against my beliefs and knowledge. Nor do I wish to be penalized for refusal of such medical procedures by not being able to enter into society or be employed.

Sadly, I feel as if my voice and attempts don't matter. I feel coerced and threatened into receiving these "vaccines". What does a person do when given the ultimatum from the highest level mandating such an infringing policy—either inject myself with what is considered by many medical experts as "**poison**" and **Experimental**; or, lose my employment and my career, and not allowed to partake in social events or even business establishments. I will be unable to take care of myself or my family, my fifteen year old daughter, and unable to find employment elsewhere because now all places require this mandatory medical treatment. I feel scared when there is no one to turn to because the policy comes from the Premier and Health Minister of our Province. I can only hope that whoever views this letter they view it with an open mind, and consider the health and well-being and Human Rights this policy infringes upon.

I hope that others within this Government share the same courage and integrity that I try my best to demonstrate, and challenge the given narrative with the information in my letter along with others presented. I put everything on the line by even writing this since it

challenges the Status Quo and goes against what many believe. But everything in this letter is by credible experts. And when that many experts all come together saying the same things, it speaks for itself. I hope to show that change is possible and necessary. If we don't act now, I believe we are headed to a grim future for the state of our wonderful Province and Country. A future where one single person / organization / entity can mandate for us—the people to follow through with any given order; and if we fail to comply then all privileges and Rights are revoked and our lives are destroyed forever.

I know many others who are in the same position as I am who may be too afraid to speak up for whatever reason, or don't have the same skills and knowledge to speak up. This letter is to advocate for the unspoken, the silent ones in distress, the ones possibly suffering mentally and emotionally like I am because of this policy, and who may be reaching their breaking point that we don't know of. Even if the data showed that it was the deadliest virus in the world—my solution would be to offer vaccines to whomever wants them, and respect the rights and wishes for those who don't, while finding alternative solutions that also does not infringe on human rights and supports the health and well-being of all.
